ORDINANCE NO. 2006-2- 2

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN  
DESCRIBED REAL ESTATE TO THE VILLAGE OF RINGWOOD, ILLINOIS

WHEREAS, Laurie Stade is the owner of the real estate legally described in the  
attached Exhibit "A"; and

WHEREAS, no electors reside on the real estate hereinafter described; and

WHEREAS, the real estate hereinafter described is contiguous to the existing  
corporate limits of the Village of Ringwood, Illinois, and is not located within any other  
municipality; and the aforesaid record owner desires annexation of said real estate to the  
Village of Ringwood, Illinois and has petitioned the Corporate Authorities of the Village of  
Ringwood, Illinois, in writing and under oath, for annexation of said real estate; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF  
TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1: The real estate legally described on the attached Exhibit "A" be and  
the same is hereby annexed to and made a part of the corporate limits of the Village of  
Ringwood, Illinois, including any and all portions of adjacent streets, roads, or highways as  
required by law:

That an accurate map of said territory is attached hereto as Exhibit "B".

SECTION 2: The Village Clerk is hereby directed to record a certified copy of this Ordinance in the Office of the Recorder of Deeds, McHenry County, Illinois. Following such recordation, a copy of this ordinance shall be filed in the Office of the Clerk of McHenry County, Illinois.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
