

Public Works Report:



Parking Ordinance Reminder – At all times of the year, parking is prohibited on all Village of Ringwood roads, except Barnard Mill Road near the post office (2 hour limit). After a snow of two inches or more, parking is not permitted in the spaces along Barnard Mill Road near the post office until after the road has been plowed shoulder to shoulder. This parking prohibition is in effect 24 hours a day. If a 2-inch or greater snowfall occurs and your vehicle is parked along the road, you must move it or have it moved immediately so plows can get through. By doing so, you will avoid being ticketed and towed. In that scenario, an individual would not only have to pay the ticket, but the towing charge as well. Your compliance with our Parking Ordinance is appreciated.



Mailbox Post – With winter on its way, this would be a good time for residents to check their mailbox and post to be sure that they are sturdy and can handle the snow roll off from the plow. If repair or replacement is needed, please take the time now to do it. If your mailbox or post falls down during the winter months, the only thing that can be done at the time is a temporary fix and mail delivery may be disrupted.

Blitzed Mailboxes – If your roadside mailbox becomes a casualty during the Village's war with the wintertime elements, the Village will repair or replace it if it was damaged from direct contact with a Village contracted-and-operated snow plow. However, if the damage is caused by a windrow (wall of flying snow) hurled by a passing plow, the Village will not repair or replace it. Sturdiness should be a consideration when you purchase and install your mailbox in a legal manner. It should be able withstand a force, weight, and sweep of snow flung by a passing plow. Replacement of mailboxes damaged as a result of being struck by a Village contracted snow plow will be a standard unit set on a wolmanized 4x4 wooden post. Please bear in mind, however, that sometimes downed mailboxes cannot be reinstalled immediately. In that case you will be required to pick up your mail at the post office.



Salt Caution – It's important to be aware that the effectiveness of road salt diminishes as the temperature drops. The lower the temperature, the less effective the salt will be. Road salt effectiveness is also reduced during freezing rain, because it's washed off the pavement by the traffic as the rain continues falling and freezing on impact. In any weather, when salt is spread, drive as if there was no salt at all. Reduce your speed and allow plenty of space between your vehicle and the one in front of you. Also, begin stopping well in advance of any stop sign or traffic signal.



Street Lights – Your Village officials would appreciate it if you would report street light outages to Village Clerk Roni Bushroe, by calling 815-321-1899. In turn, the Village will notify ComEd of the outage and they will send a crew out to repair the light.

Village Hall Roof Replaced

Your Village Officials hired AMB Roofing and Sheetmetal of Johnsburg (Low Bidder) in the amount of \$42,675.00 to replace the roof on the Village Hall. The old asphalt shingled roof was installed in 1999. The roof was supposed to last for 30 plus years. Unfortunately the roof failed way before its time. As a result, after a lot of consideration your Village officials decided it would be worth the investment to replace the old asphalt shingle roof with a metal roof. In addition, the metal roof is a good fit for the barn style roof and should last significantly longer than any asphalt shingled roof currently on the market.

NIGEAC Electrical Aggregation User:

As you may know, the Village of Ringwood entered into an electrical aggregation purchasing co-op (NIGEAC) in July 2012 as a way to save residents money on their electric bill. The very first month of the program, residents saw an average savings of \$37.97 per month per household - a savings of almost 43% over Commonwealth Edison's (ComEd) rate.

At the end of that contract, NIGEAC sought new competitive bids for power. In July of 2015, NIGEAC entered into a two-year contract with Constellation Energy Services, Inc (CES) and secured a low rate of 6.89 cents per kilowatthour for residential customers. As a condition of accepting this contract, NIGEAC required that CES include a no termination- fee exit option for residents who elected to to return to ComEd service at any time during the term of the agreement.

The fixed rate NIGEAC has negotiated for its residents has saved them almost \$500 per household on average over the course of the program. However, because of changes in the power market, ComEd's rate has been fluctuating and may be lower than NIGEAC's 6.89 cents/kWh.

Because of this change in pricing, the village of Ringwood would like to remind residents that you may exit the NIGEAC program at any time without penalty by calling Constellation at 1-844-257-8244. Please have your ComEd bill available when calling, as you will need to provide your account number.

- Approve hiring AMB Roofing & Sheetmetal of Johnsburg (Low bidder) to replace the roof on the Village Hall.

At the August Village Board meeting the Village Board voted unanimously to approve the above action, except Trustee Hewes and Kepes who were absent.

September 2016

- Approve amendment to the Declaration of covenants, conditions and restrictions to the Pioneer Oaks of Ringwood subdivision regarding outbuildings.
- Approve hiring Hiller property maintenance to landscape around the Village monument sign located on Ringwood Road across from the new fire station.

At the September Village Board meeting the Village Board voted unanimously to approve the above action, except Trustees Bauer and Reinwall who were absent.

October 2016

- Approve a new five year contract with Waste Management for solid waste, recycling and landscape waste removal.
- Approve hiring Anchor Building Solutions, Inc. and Battaglia Inc. (Low bidders) to insulate and build out the north side of the interior space of the Public Works building.
- Approve 2017 Village Board regular meeting schedule.

At the Village Board October Village Board meeting the Village Board voted unanimously to approve the above action.

Possible Future Action by the Village Board:

- Consider Tax Levy
- Consider hiring a contractor to install 2017 downtown steetscape improvements.
