Public Works Report:



Parking Ordinance Reminder - At all times of the year, parking is prohibited on all Village of Ringwood roads, except Barnard Mill Road near the post office (15 minute limit). After a snow of two inches or more, parking is not permitted in the spaces along Barnard Mill Road near the post office until after the road has been plowed shoulder to shoulder. This parking prohibition is in effect 24 hours a day. If a 2-inch or greater snowfall occurs and your vehicle is parked along the road, you must move it or have it moved immediately so plows can get through. By doing so, you will avoid being ticketed and towed. In that scenario, an individual would not only have to pay the ticket, but the towing charge as well. Your compliance with our Parking Ordinance is appreciated.



Mailbox Post - With winter on its way, this would be a good time for residents to check their mailbox and post to be sure that they are sturdy and can handle the snow roll off from the plow. If repair or replacement is needed, please take the time now to do it. If your mailbox or post falls down during the winter months, the only thing that can be done at the time is a temporary fix and mail delivery may be disrupted.

Blitzed Mailboxes - If your roadside mailbox becomes a casualty during the Village's war with the wintertime elements, the Village will repair or replace it if it was damaged from direct contact with a Village contracted-and-operated snow plow. However, if the damage is caused by a windrow (wall of flying snow) hurled by a passing plow, the Village will not repair or replace it. Sturdiness should be a consideration when you purchase and install your mailbox in a legal manner. It should be able withstand a force, weight, and sweep of snow flung by a passing plow. Replacement of mailboxes damaged as a result of being struck by a Village contracted snow plow will be a standard unit set on a wolmanized 4x4 wooden post. Please bear in mind, however, that sometimes downed mailboxes cannot be reinstalled immediately. In that case you will be required to pick up your mail at the post office.



Salt Caution – It's important to be aware that the effectiveness of road salt diminishes as the temperature drops. The lower the temperature, the less effective the salt will be. Road salt effectiveness is also reduced during freezing rain, because it's washed off the pavement by the traffic as the rain continues falling and freezing on impact. In any weather, when salt is spread, drive as if there was no salt at all. Reduce your speed and allow plenty of space between your vehicle and the one in front of you. Also, begin stopping well in advance of any stop sign or traffic signal.

Trick or Treating Hours



Trick or Treating hours in Ringwood will be on Saturday, October 31, 2020 from 3:00 to 7:00pm. Due to the Covid-19 Pandemic, please review the following message and guidelines for neighborhood Trick or Treating from the Illinois Department (IDPH) for Tick or Treating in 2020. Have a happy and safe Halloween. IDPH - Halloween Guidance 9/30/2020



As we enter fall, families are starting to plan for the upcoming holiday season, starting with Halloween. Because some of the traditional ways to celebrate this holiday do not allow for proper social distancing, the Illinois Department of Public Health (IDPH) is providing the following guidance to allow for safe Halloween celebrations. Trick-or-treating events need to incorporate social distancing, masking, and proper handwashing, as well as adherence to event size limitations. For this year, it would be safest to plan special events at home, using social media and other meeting platforms to connect with family and friends. However, for those who choose to celebrate in person IDPH is offering the following guidance. Please reference your local health department, village/city, or county information for guidance or policies specific to your location as well. As a reminder, if you think you could have COVID-19 or may have been exposed to someone with COVID-19, you should not participate in in-person Halloween festivities and should not give out candy to trick-ortreaters. Individuals at increased risk for severe illness should not attend in-person Halloween gatherings. Neighborhood trick-or-treating

- 1) As an alternative to door-to-door trick-or-treating, anyone who would like to distribute treats should leave individually wrapped candy or treats on a table, on their front walkways, sidewalks, or any outdoor space that allows for at least 6 feet of social distance from the door. The individually wrapped candy should be spread out so each piece is not touching another. Anyone distributing candy or treats should wash their hands properly for at least 20 seconds before placing the candy on the table and when replenishing.
- 2) All individuals participating in trick-or-treating, including those passing out candy should maintain social distance of least 6 feet and wear proper face coverings. A costume mask, such as those worn for Halloween, is not a substitute for a face covering. If face coverings are worn under costume masks, please ensure this does not create breathing problems, and if so, discard the costume mask.
- 3) Only household members should trick-or-treat together, and they should maintain 6-feet social distance from other trick-or-treaters at all times. Mixed household trick-or-treaters are discouraged.
- 4) Alcohol-based hand sanitizer should be carried and used frequently.
- 5) Candy collected during trick-or-treating should not be consumed until after handwashing. As always, a parent/guardian should check all candy to make sure it is wrapped and should discard unwrapped candy.
- 6) And, of course, practice good dental hygiene as well.
- 7) Outdoor areas are preferred for trick-or-treating. Enclosed indoor areas, like apartment buildings, present greater risk of transmission. Open doors and windows as appropriate to promote increased ventilation.

Nature's Scholars is so grateful to be able to open our School Age License Exempt program (Nature's Scholars Off-Grid) at the Ringwood Village Hall. When School District 12 decided to do remote learning, many families where put in a bind. 
